Members who plan to announce upcoming events are asked to provide the Secretary with written information about the event to ensure accuracy in the minutes.

Gloria Bloodsaw (speaking for Treasurer Kayla McGinnis), informed membership that the Coalition's bank balance stands at \$3800.00.

Gloria Bloodsaw would like upcoming meeting hosts to submit their workshop outline and bio by this Friday when she intends to start updating our website with that information. Gloria will receive training in website maintenance by Lisa Snipes. Gloria informed membership that Diane Feeney's daughter, Taylor, will assist with the Coalition's social media needs.

The deadline to apply for the Jim Russell scholarship is May 1, 2019. Scholarship information can be found on the Coalition's website. A successful applicant may be awarded up to \$500.00. This opportunity is available to a person in recovery pursuing an educational objective, or an individual pursuing CADC certification. Priority consideration is given to CADC seekers.

Larry Dunbar thanked the Coalition on behalf of the USF student who was awarded the Jim Russell scholarship in 2018. News of the award was published in the Chicago Tribune and included information about the recipient, our Coalition, and the person for whom the award is named, Jim Russell.

Announcements:

Larry Dunbar announced the University of St. Francis will offer a new certificate program for people seeking CADC certification who already have their Master's Degree and experience. This one year, three-semester program, scheduled to start in 2019, will provide classes, internships and supervision.

USF is also developing a special tuition rate for employees of the Department of Corrections.

Sidebar: Beth Fuqua inquired whether people with a criminal history can secure employment if they obtain certification in substance abuse treatment. Criminal history is not an obstacle to employment for many treatment facilities, according to Robert Snipes. Expungement was also suggested.
